Waiver of Liability:

The participant shall participate in the event at his own risk. In the absence of an exclusion of liability clause, the participant shall be held responsible for any damages caused by him or his vehicles according to civil and penal law.

By signing and submitting this form, the driver and passenger waive any claims for damages incurred in connection with the event against

- *the organiser, sports supervisors, authorities and all other persons participating in the organisation of the event,*
- *the road works authority in the event of damages incurred due to the nature of the roads including all appurtenances used in connection with the event*
- *the performing and vicarious agents of all of the above-mentioned persons and authorities,*

excepting damages caused by injury to life, body or health resulting from a wilful or negligent breach of duty – including by a legal representative or performing agent of the category of people released from liability – and excepting any other damages resulting from a wilful or grossly negligent breach of duty - including by a legal representative or performing agent of the category of people released from liability; they shall also waive claims for damage of any kind against other participants (drivers, passengers), their assistants, the owners and keepers of other vehicles, excepting damages caused by injury to life, body or health resulting from a wilful or negligent breach of duty – including by a legal representative or performing agent of the category of people released from liability – and excepting any other damages resulting from a wilful or grossly negligent breach of duty - including by a legal representative or performing agent of the category of people released from liability.

Exclusion of liability becomes applicable to all parties concerned effective immediately upon submittal of this registration form.

The waiver of liability applies to claims for whatever legal reasons, particularly to damage claims from contractual as well as non-contractual liabilities, as well as to claims arising from tortious acts. Implicit exclusions of liability shall remain unaffected by the aforementioned exclusion clause. By submitting this registration form, the keeper/driver/passenger shall take note that insurance coverage within the scope of automobile insurance (third-party vehicle insurance, collision damage insurance, insurance on hull and passenger accident insurance) does not apply to damages incurred during the event. He shall also undertake to inform the owner of the vehicle employed thereof.

excepting damages caused by injury to life, body or health resulting from a wilful or negligent breach of duty – including by a legal representative or performing agent of the category of people released from liability – and excepting any other damages resulting from a wilful or grossly negligent breach of duty - including by a legal representative or performing agent of the category of people released from liability.

The waiver applies to claims on all legal grounds, especially for claims for damages arising from contractual and non-contractual liability and for claims arising from a tort. Implicit exclusions from liability remain unaffected by the above waiver.
